

He also has the honour of being the first to find the Simius Roadide-Skipper, Ambysantes simius, in Canada. Ron was also a pastor with the Fort Qu'Appelle Apostolic Church and spent many years working with First Nations people.

Thanks to each of the executive and committee members for doing a commendable job executing the duties of their elected offices.



The Saskatoon Prairieland Exhibition Corp. hosted this year's GardenScape "Little Green Thumbs School Tour Program" on Thursday, March 25th and Friday March 26th. Volunteers

from Agriculture and Agri-Food Canada and members of the Entomological Society of Saskatchewan talked to 717 Grade 2-3 students from 22 schools in the Saskatoon area.

Dear Ms. Sagle,

In response to your request for additional information regarding activities of the Entomological Society of Saskatchewan (ESS), please find below a detailed list of our events, awards and activities. Also, please find enclosed two copies of our recent News Letters.

Meetings

The ESS meets twice a year, usually the spring and fall. The fall meeting includes oral and poster presentations about various aspects of insects, and the presentation of two awards.

Awards

The amendment to establish an Awards Committee was made due to the recent approval by the society of a third society award, the ESS Travel Award. Prior to the formation of this overseeing committee, individual members met to decide the suitability of student applicants for the Anhar R. Brooks Memorial Prize and the Best Paper A ward. This amendment was approved to consolidate the award decision-making process within the society. The Travel Award is offered to members of the Entomological Society of Saskatchewan for the purposes of assisting in travel costs associated with attending an entomological conference or to conduct entomological research. The Anhar R. Brooks Memorial Prize is awarded to a university student who has made an outstanding contribution to entomology in Saskatchewan and maintains an acceptable academic average. The Best Paper Award is given for the best student paper presented at the fall meeting.

Newsletter

A newsletter is produced two or three times a year. This letter contains information regarding upcoming meetings and field collection trips, reports of new insects in the province, status of important insect species, and other general information that is of interest to the society.

Insect Surveys

The ESS is active in observing, identifying and collecting insects. For example, ESS volunteers collected representative insects, pinned specimens, designed displays and contributed this base-line insect collection to the Grasslands National Park for their use as a research and public display tool. Each year in late June and July, ESS members participate in an annual North America-wide butterfly count. Society members also participate in field trips from time to time, highlighting entomological and ecological features. In 2009, ESS visited the Great Sand Hills region of the province and documented the occurrence of tiger beetles unique to this ecological niche.

Talks and Presentations

Members of the society are active in giving talks, presentations and displays at schools, field days, garden shows, senior homes and shopping malls. Presentations include living and preserved specimens and slides of insects belonging to the society. As well, information is provided on how to collect and display insects. A dissecting microscope is available for preparation and demonstration of insect material. Interested groups are invited to contact the ESS regarding requests for presentations.

Although the Board Meeting minutes are available the ESC website several key decisions of the Board and AGM meeting are highlighted below as extracted from the draft minutes:

Ad Hoc Committee for TCE publisher

This Committee received and evaluated proposals from three publishers for publishing TCE (Taylor & Francis, NRC Research Press, and Cambridge University Press). Following an exhaustive round-

table discussion comparing proposals by each publisher, the Board decided unanimously that Cambridge University Press offered the best option for publishing TCE. A contract of 1 year with NRC Research Press should be signed as the switch to Cambridge University Press is anticipated to start January 2012. S. Brooks and K. Floate will head negotiations with the new publisher.

TCE Editor Position

R. Bennett has resigned as of September 2011 and recommended a minimal overlap of 3 months with the new Editor. P. Mason will investigate ways to have an Editor-in-Chief for 2 years with financial support for editorial activities to smooth the transition between NRC Research Press and Cambridge University Press.

Annual Meeting Committee

The ESC accepted the ESO proposal to host the 2013 JAM in Guelph, Ontario, to celebrate the 150th anniversary of the ESC/ESO. To restore the east-west tradition for holding meetings, the ESC should ask to again defer the JAM meeting with SEQ to 2015 and ask the ESS to move to 2014.

The Chair B. Elliott proposed changes to the organizational structure of joint annual meetings.

Three points were proposed:

1) The creation of a centralized registration system for the annual meeting

The Board approved and charged the incoming Treasurer S. Brooks to evaluate the possibility to have a bank account for the annual meeting.

2) The utilization of an ESC selected Scientific Program Chair

The Board did not approve this but recommended rather that a message be sent to each organizing committee to offer help for the scientific program from the Governing Board when needed and this request should pass through their regional directors. To facilitate the work of the Scientific Committee and reduce their work, the Board suggested passing over files regarding the JAM program to the next organizing committee.

3) The creation of a centralized Fund-Raising Committee for the annual meeting
The Board approved this recommendation and suggested that the Fund-Raising Committee be reactivated.
